## 3. CHILD WELFARE AND SAFEGUARDING



- At Beacons Football Club every child matters and we are committed to the safeguarding and welfare of every child.
- The Child Welfare Officer ensures that all Government policies and agendas are being met by the club. The Child Welfare Officer (CWO) is responsible for making sure that all relevant training and clearance has been given to everyone involved and ensuring the club understands and meets its responsibilities.
- The CWO looks after any concerns that may arise with a child and has been trained to deal with sensitive issues. The CWO ensures all Child protection policies; guidance and practice are delivered safely and will involve any agencies if needed to protect a child's welfare.

# 4. FEES AND SUBS

Beacons Football Club prides itself on the competitive subs we charge to allow all children to be involved in the team sport. The subs that you pay run our club by providing:

Fees for the 2024/25 season will remain the same as fees in place for the past six years:

## **Registered Players (Playing matches on Sunday)**

- £50 registration fee (all players) to be paid by all players upon registration and prior to the first league game on (SELKENT: expected 14<sup>th</sup> September 2024)
- Mini-soccer (U7-U10 teams): £35 a month subs for October
   – April inclusive (7 Payments
   made by direct debit on the 1<sup>st</sup> day of each month)
  - Or a single subs payment amount of £210 (£35 saving) can be paid by 1st October.
- Youth-soccer (U11 teams upwards) £40 a month for October– April inclusive (7 Payments made by direct debit on the 1<sup>st</sup> day of each month)
  - Or a single subs payment amount of £240 (£40 saving) can be paid by 1st October.
- Sibling discount (all ages) £10 discount per month on the second child subs payments
  - (additional discount on the second child for annual payment saving the equivalent of one month's subs )

## Unregistered Players (Training and 'friendly' matches only)

£5 per week / £20 per month to cover training costs

## HOW TO PAY FOR YOUR SUBS/FEES

- Subs and Fees are due on the 1st of each month via a direct debit or direct transfer
- To enable our managers and coaches to focus on coaching and developing the children, payments must be made directly into our bank account.
- Reference: Please use your child's team and name of player (ie U9RPatel or U16JSmith)
- Non-payment may result in player suspension. If anyone is experiencing financial hardship and is unable to pay, please speak to your manager, coach or a member of the management committee so that we can support you.

We use the information reported through adverse incidents, Welfare issues complaints and concerns raised to identify where the gaps are and need for improvement, this response enables changes to enhance the running of the club.

## **GENERAL INFORMATION**

- Please inform a member of the team with any changes in circumstances, we are here to help and to ensure your child gets the most out of playing for the club.
- If you are unable to make a match or training session please inform your coach / manager with as much notice as possible.
- Please arrive 30 minutes before kick-off for league matches or tournaments.
- Please remove all your rubbish with you when you leave training or matches, it is unfair to expect the team managers to clear up after spectators
- We want everyone to be able to access our webpage and participate in our social media pages in addition to other social networking opportunities, so we are clarifying the expectations around responsible use which are aligned with the FA guidelines. For many people these guidelines will be common sense and you will be complying with them already.



# 6. CODES OF CONDUCT



## PLAYERS' CODE OF CONDUCT

- Beacons FC will provide you with a safe environment to learn about
- football. We will coach and support you so that you have a fun and enjoyable
- experience while you develop and do the best you can.
- At Beacons we want everyone to be safe and happy. We want everyone to have fun and to enjoy playing for our teams. If you don't feel safe, speak to your manager or another Beacons coach.

### What we expect from you -

So that everyone can have fun, there are rules you need to follow when playing for Beacons. If the rules are broken you may face match bans or be asked to leave the team.

- We ask you to:
- Try your best always
- Be a team player even if my team is losing
- · Shake hands with the other team at the end of the game
- Play fairly
- Listen to my coach / manager
- Respect match officials
- · Not cheat or waste time
- Not swear or use bad language
- Not hit, punch, kick or be violent in any other way towards others
- Not call people names or be unkind to others
- Not sulk
- We would also like you to talk to someone if you are unhappy about anything in the club (for example your parent/guardian, coach or the club's child welfare officer).

## SUPPORTERS' CODE OF CONDUCT

- Beacons FC is committed to the safeguarding of every child's welfare. We support the FA's Respect
  programme to ensure football can be enjoyed by everyone in a safe and positive setting. We
  provide safe, friendly and fun surroundings for our children to grow and learn in a sporting
  environment.
- The FA's Respect programme is aimed at tackling unacceptable behaviour across the whole game. Parents/Guardians are responsible for the spectators they bring to matches and are asked to behave in a manner set out below to protect the welfare of the children. Anyone not adhering to the code will result in action set out in the club's disciplinary procedure.

#### What we expect from you -

- Remain outside the field of play and behind the designated spectator area (where provided)
- Do not engage in offensive, abusive or insulting language
- Never use aggressive or violent behaviour
- Respect the match official decisions
- · Let the Coach / Manager do their job and not confuse players by telling them what to do.
- Never criticise a player for making a mistake, mistakes are part of learning
- · Encourage Players to respect the opposition and match officials
- Applaud good effort and good play as well as success
- Remember children play for fun
- We would also like you to report any incidents or concerns about any child's wellbeing to a club official or the club's child welfare officer.

# 6. CODES OF CONDUCT



## CLUB OFFICIALS CODE OF CONDUCT

Beacons Football Club officials must consistently display high standards of behaviour and be role models for players, parents and spectators.

## Team Managers/Coaches must:

- Place the well-being, safety and enjoyment of each player above everything including the development of performance and winning
- Respect the rights, dignity and worth of everyone and treat them equally
- Explain exactly what is expected from each player
- Refrain from, and refuse to tolerate, any form of bullying
- Develop mutual trust and respect from every player to build their self esteem
- Encourage each player to accept responsibility for their own behaviour and performance and to play in the correct spirit
- Ensure all activities are appropriate for player's ability level, experience, age and maturity.
- Involve all children in the game regardless of their ability.
- · Display and promote a high standard of behaviour
- Co-operate with others in football (e.g. officials, doctors) in each player's interest.
- Ensure that parents / guardians understand the expectations that have been set
- Handle any unruly behaviour from the team's supporters
- · Remind supporters of the supporter's code of conduct, if required
- Ensure that Referees and Match Officials (including parents and spectators who are officiating as referees and assistant referees) are treated with respect
- Respect match officials' decisions
- Not, under any circumstances, remove the team from the pitch without the permission of the referee
- · Never enter field of play without the referee's permission
- Never engage in or tolerate abusive aggressive or violent behaviour to officials, players or spectators
- · Never engage in public criticism of the match officials
- Adhere to all guidelines laid down within the Constitution and Rules of the Football Association
- Never condone violations of the Laws of the Game or behaviour contrary to the spirit of the Laws or relevant rules and regulations or with the use of prohibited substances or techniques
- Show respect to others involved in the game including opposition, coaches, managers and spectators
- Never engage in or tolerate offensive insulting or abusive language
- Must always promote the League's Code of Conduct and emphasise the positive aspects of the sport to players, parents and spectators alike
- · Must not exert undue influence to obtain personal benefit or reward

## 7. REGISTRATION FORM AND DISCLAIMER



### **Data Protection:**

Officers and managers of Beacons FC will treat all information on this form as confidential. We may, from time to time, use your email or mobile number to contact you about club activities. We will not share your information with any other party without your permission (except in the event of our League (SELKENT) or County association (London FA) needing the information for disciplinary issues). A copy of our Privacy Notice is available on request.

#### Health disclaimer:

I have informed the club of any health conditions and what action to take in an event of an emergency. I understand that I am fully responsible for my child's health needs while he is taking part in activities within the club and on the club grounds.

### Safeguarding:

Beacons FC will do everything in its power to protect the players from harm, both physically and emotionally. We will treat any complaints about abuse seriously and investigate where necessary. Complaints can be referred to the child welfare officer or any club official.

## Use of Photography:

Coaches and Club Officials will from time to time photograph or video matches or training to post on our website or other media, e.g. Facebook, or to use as an aid to training. If at any point you have concerns about your child appearing in a photo (e.g. the child is subject to care proceedings), it is important to discuss this with your child's Coach, our Club Secretary or Welfare Officer who will ensure the club is made aware and appropriate and agreed action is taken. We do NOT identify a child or children by name when posting a photograph or video online or in the press, or publish any other personal details or information that will assist a third party in identifying the child. The Club does NOT allow images to be recorded in changing rooms, showers or toilets – this includes the use of mobile phones that record images. When taking photos or video, we will focus on the activity rather than the individual. We will ensure that all children featured in a photo or video are appropriately dressed with a minimum of shirt and shorts. Club Officials should aim to take pictures which represent the broad range of youngsters participating safely in football e.g. boys and girls, disabled people, ethnic minority communities.
